RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE is made as of February 3, 2012 by SUNTRUST BANK, as Agent for the Lenders ("*Secured Party*").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 1, 2010 (the "*Security Agreement*"), by and between CEQUINT, INC., a Washington corporation (the "*Grantor*") and Secured Party, the Grantor granted a security interest to the Secured Party in certain Trademark Collateral (as defined in the Security Agreement), including the Trademarks set forth on Schedule I thereto; and

WHEREAS, Secured Party recorded a security interest in said Trademark Collateral with the Assignment Division of the United States Patent and Trademark Office on October 4, 2010 at Reel 4289, Frame 0643; and

WHEREAS, the Secured Party has agreed to release its rights under said Security Agreement and to re-convey to Grantor any and all rights in and to the Trademark Collateral.

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby terminates, releases and discharges its security interest in and to all of Grantor's right, title and interest in and to the Trademark Collateral originally granted to Secured Party pursuant to the Security Agreement.
2. Secured Party, to the extent granted in the Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by Secured Party, any and all of its right, title and interest in and to the Trademark Collateral and all goodwill associated therewith originally granted to Secured Party pursuant to the Security Agreement.
3. Upon the request of Grantor, Secured Party further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest.

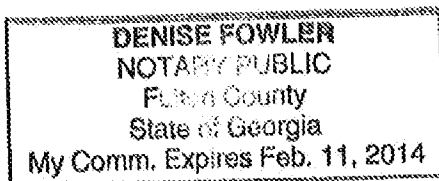
