TERMINATION OF TRADEMARK SECURITY AGREEMENT

This Termination of Trademark Security Agreement (this "Termination"), dated as of February 6, 2012, is executed by Bank of Scotland plc ("Secured Party"), in favor of Illuminas Global LLC and The Gate Worldwide LLC (collectively, the "Grantors").

RECITALS

WHEREAS, the Grantors and Secured Party are party to that certain Facility Agreement dated November 12, 2005 and amended and restated on the Effective Date (as defined in an amending agreement dated June 18, 2010 between, among others, Media Square plc and Bank of Scotland plc in various capacities) (and as amended, restated, supplemented or otherwise modified from time to time, including all schedules thereto, the "Facility Agreement") among Media Square plc, a company incorporated in England and Wales, as borrower, the lenders party from time to time thereto as lenders, and Bank of Scotland plc as agent;

WHEREAS, in connection with the Facility Agreement, the Grantors and Secured Party entered into that certain Trademark Security Agreement (the "Trademark Security Agreement"), dated as of November 12, 2005 and that certain Supplemental Trademark Security Agreement (the "Supplemental Trademark Security Agreement"), dated as of August 2, 2010;

WHEREAS, pursuant to the Trademark Security Agreement and the Supplemental Trademark Security Agreement, the Grantors granted to Secured Party a security interest in certain "Trademark Collateral" including certain trademarks; and

WHEREAS, the Facility Agreement and the Trademark Security Agreement and the Supplemental Trademark Security Agreement have been terminated.

NOW, THEREFORE, Secured Party agrees as follows:

1. Secured Party is executing and delivering this Termination as further evidence of the termination of the Trademark Security Agreement and the Supplemental Trademark Security Agreement.

2. Secured Party claims no right, title or interest whatsoever in or to any of the "Trademark Collateral" described in the Trademark Security Agreement and the Supplemental Trademark Security Agreement in connection with both such agreements, and, accordingly, Secured Party expressly terminates its security interest in the trademarks listed on Exhibit A hereto, which security interest was evidenced by the recordation of the Supplemental Trademark Security Agreement with the United States Patent and Trademark Office on August 6, 2010.


