RELEASE OF SECURITY AGREEMENT

This Release of Security Agreement (this "Release") is given as of February 9, 2012, by BANK OF AMERICA, N.A. (as successor to Bank of America National Trust & Savings Association), a National Banking Association, located at 1455 Market Street, 12th Floor, San Francisco, California 94103 (the "Agent") for the benefit of SPALDING SPORTS WORLDWIDE, INC. (the "Debtor");

WHEREAS, Debtor has fully discharged and satisfied the obligations secured by the Intellectual Property Supplement, dated as of October 24, 2002 ("IP Supplement"). The IP Supplement was recorded in the United States Patent and Trademark Office at Reel 2613/Frame 0898 against the trademarks attached hereto as Exhibit A (the "Trademark Collateral"); and

WHEREAS, Debtor has requested that the Agent release, and the Agent is willing to release, subject to the terms hereof, its security interest, and any other right, title and interest it may have in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

Agent does hereby terminate and release, without any recourse, representation or warranty, any and all security interests and all other right, title or interest that it may have in, to or under, the Trademark Collateral and thereby discharge the recordation of the IP Supplement against the Trademark Collateral.
