



BRASSCRAFT MANUFACTURING COMPANY

Pursuant to Title 8, Section 252 of the General Corporation Law of the State of Delaware, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name and state of incorporation of each of the constituent corporations is as follows:

- (a) Cobra Products, Inc., a Delaware corporation; and
- (b) BrassCraft Manufacturing Company, a Michigan corporation

SECOND: The Agreement and Plan of Merger dated as of December 20, 2011, between Cobra Products, Inc. and BrassCraft Manufacturing Company has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8, Section 252 of the General Corporation Law of the State of Delaware.

THIRD: The name of the surviving corporation is BrassCraft Manufacturing Company, a Michigan corporation.

FOURTH: The Articles of Incorporation of the surviving corporation shall be its Articles of Incorporation.

FIFTH: The merger of Cobra Products, Inc. into BrassCraft Manufacturing Company shall be effective on January 1, 2012, at 12:01 a.m. Eastern Time.

SIXTH: The Agreement and Plan of Merger is on file at 39600 Orchard Hill Place, Novi, Michigan 48375, the place of business of the surviving corporation.

SEVENTH: A copy of the Agreement and Plan of Merger will be furnished by the surviving corporation on request, without cost, to any stockholder of the constituent corporations.

EIGHT: The surviving corporation agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of the surviving corporation arising from this merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the General Corporation Law of the State of Delaware, and irrevocably appoints the Secretary of

Secretary of State shall mail any such process to the surviving corporation at c/o Legal Department, Masco Corporation, 21001 Van Born Road, Taylor, Michigan 48180.

NINTH: The merger is deemed to be a reorganization for federal income tax purposes under Section 368(a)(A) of the Internal Revenue Code.
