**RELEASE AND TERMINATION
OF
TRADEMARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Trademark Security Agreement, dated as of May 31, 2011 (the "Trademark Security Agreement"), was executed by Paulsboro Refining Company LLC (the "Pledgor"), covering the Trademark Registrations and Applications more fully described on Schedule 1 annexed hereto and made a part hereof (the "Trademark Registrations and Applications") in favor of UBS AG, Stamford Branch, in its capacity as administrative agent and a co-collateral agent for the Lenders party to that certain Amended and Restated Revolving Credit Agreement, dated as of May 31, 2011 (as amended, supplemented or otherwise modified to date, the "Revolving Credit Agreement") (in such capacity as administrative agent and a co-collateral agent, the "Secured Party"). Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Trademark Security Agreement.

Pledgor has requested and the Secured Party has agreed to release the Trademark Registrations and Applications and discharge the Trademark Security Agreement.

The Secured Party hereby releases all of its right, title and interest in and to the Trademark Registrations and Applications which were pledged, mortgaged and set over or otherwise made subject to a lien in favor of the Secured Party by Pledgor pursuant to the Trademark Security Agreement and terminates the Trademark Security Agreement.


This Release and Termination shall be governed by and construed and enforced in accordance with the internal laws (as opposed to conflicts of law provisions) of the State of New York.


