## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (the “**Release**”) is dated as of November 14, 2011. Reference is made to that certain Pledge and Security Agreement dated as of February 3, 2003 by and among Schoolhouse Furniture, Inc., a Delaware corporation (“**Company**”), Sagus Acquisition Corp., a Delaware corporation now known as Sagus International, Inc. (“**Holdings**”), each of the direct and indirect subsidiaries of Company, including Artco-Bell Corporation, a Texas corporation (“**Grantor**”), and BNP Paribas, as administrative agent in such capacity, (“**Secured Party**”) (as such Pledge and Security Agreement may be amended, restated, supplemented or otherwise modified from time to time). Capitalized terms not defined in this Release have meanings set forth for such terms in the IP Supplement, as defined below.

**WHEREAS**, pursuant to that certain IP Supplement to Pledge and Security Agreement, dated as of April 11, 2005 (the “**IP Supplement**”), Grantor pledged to Secured Party a security interest in all of its right, title or interest in or to the trademarks attached to the IP Supplement, including the trademarks listed on Schedule A (the “**Trademarks**”) and all proceeds and products of any and all of the foregoing;

**WHEREAS**, the IP Supplement was recorded in the United States Patent and Trademark Office on April 15, 2005 at Reel/Frame 3067/0672; and

**WHEREAS**, pursuant to the terms of a payoff letter dated as of November 14, 2011, among Company, Holdings, each of the direct and indirect subsidiaries of Company, including Grantor, Secured Party desires to release its interest in the Trademarks.


**NOW THEREFORE**, Secured Party hereby notifies, acknowledges to and agrees with Grantor that the security interest in the Trademarks granted by Grantor to Secured Party pursuant to the terms of the IP Supplement, is terminated and released as of the date hereof, and that Secured Party hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the IP Supplement and to the Trademarks.


Secured Party hereby agrees to take such further actions and to execute such further documents as Grantor may reasonably request to effect and evidence this Release, including, without limitation, the execution of any filings, statements, amendments, recordings or other instruments required to maintain the application or registration of the Trademarks and record the chain of title accordingly with the United States Patent and Trademark Office.
