CERTIFICATE OF INCORPORATION
OF
WEBROOT SOFTWARE, INC.**

Webroot Software, Inc., a corporation organized and existing under and by virtue of the Delaware General Corporation Law (the "**Company**"), does hereby certify:

FIRST: The name of the Company is Webroot Software, Inc.

SECOND: The date on which the Certificate of Incorporation of the Company was originally filed with the Secretary of State of the State of Delaware is January 16, 2007.
