TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is effective as of June 27, 2011 (the "Effective Date"), by and between TCI Education, Inc. ("Assignor"), and High-Tech Institute, Inc. ("Assignee").

Whereas; Assignor owns various common law rights in the trademarks and trademark applications listed on Exhibit A hereto (the "Marks").

Whereas, Assignor now wishes to assign all its rights, including the goodwill embodied therein, in the Applications to Assignee, and to effectuate that transfer, Assignor and Assignee have entered into this Assignment.

1. Assignment of Trademark Rights. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, conveys, transfers and assigns unto Assignee, effective as of the Effective Date, all of Assignor's right, title and interest in and to the Marks, including without limitation, any and all goodwill and all common law rights, including any and all legal and equitable causes of action for any past, present or future infringement, and the ability for any trademark registrations to issue in the name of Assignee, such Marks to be held and enjoyed by Assignee and its successors and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.
2. Further Actions. Assignor hereby agrees, upon request of Assignee, and without further remuneration, to promptly provide Assignee with any reasonable assistance relating to perfecting the transfer of all of the rights conveyed herein and vesting of full and complete title in Assignee, and relating to enforcing and defending those rights, including but not limited to executing any and all papers for those purposes, and testifying on Assignee's behalf about this Assignment.
3. Severability. If any provision of this Assignment or the application thereof is held to be invalid, void or unenforceable for any reason, the remaining provisions not so declared will be construed so as to comply with the law, and will nevertheless continue in full force and effect without being impaired in any manner whatsoever.
4. Binding Effect. This Assignment shall apply to, be binding in all respects upon, and inure to the benefit of Assignor and Assignee and their respective legal representatives, successors and assigns. Further, Assignor and Assignee acknowledge and agree that the recitals are incorporated into this Assignment as they effectuate the true intent of the parties.
5. Counterparts. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same instrument. Any facsimile or electronic copy hereof or signature hereon shall, for all purposes, be deemed an original.
