INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (this "Release") is made as of January 10, 2012 (the "Effective Date"), by Wells Fargo Bank, National Association ("Wells Fargo"), in favor of American Underwater Products dba Oceanic and Ocean Pulse, Inc. dba Aeris Corporation ("American Underwater").

WHEREAS, the Security Agreement was recorded on June 30, 1999 with the United States Patent and Trademark Office with respect to trademarks and patents; and

WHEREAS, the Secured Obligations have been paid and satisfied in full, and this Release is being executed to acknowledge and memorialize the release by Wells Fargo of the Security Interest in the Released Intellectual Property.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wells Fargo agrees as follows:
