## TRADEMARK ASSIGNMENT AGREEMENT

The terms and covenants of this Trademark Assignment Agreement shall inure to the benefit of Assignee, its successors and assigns, and shall be binding upon Assignor and its successors and assigns.

This Trademark Assignment Agreement may be executed in one or more counterparts, each of which will be deemed to be an original and all of which, when taken together, will be deemed to constitute one and the same Trademark Assignment Agreement.

This Trademark Assignment is further documentation of the assignments, transfers and conveyances contemplated by the Surrender Agreement, and is subject to all of the terms, provisions and conditions thereof. To the extent that any term or condition of this Trademark Assignment conflicts with any term or condition of the Surrender Agreement, such term and/or condition of this Trademark Assignment shall be deemed amended so as to be consistent with the terms and conditions of the Surrender Agreement:
