RELEASE AND ASSIGNMENT OF TRADEMARKS

THIS RELEASE AND ASSIGNMENT OF TRADEMARKS, dated as of March 4, 2010, is entered into by and among Corvest SPV LLC, a Delaware limited liability company (the "Company"); Ableco Finance LLC, a Delaware limited liability company, in its capacity as Collateral Agent (the "Collateral Agent" and, together with the Company, the "Assignors") and Corvest Acquisition, Inc., a Delaware corporation (the "Assignee").

WHEREAS, the Company, Collateral Agent and Assignee are parties to that certain Sale Agreement, dated as of March 4, 2010 (as amended, modified, restated or supplemented, the "Sale Agreement"), pursuant to which the Assignors have agreed to sell, convey, transfer, assign and deliver to Assignee, and Assignee has agreed to purchase and acquire from the Assignors, all of the right, title and interest of Assignors in and to the trademark registrations listed on Schedule A hereto, and all common law rights associated therewith, together with all goodwill arising from the use of and symbolized by said trademarks (the "Trademarks"), among other Purchased Assets (as defined in the Sale Agreement);

WHEREAS, Collateral Agent desires to release any and all claims, liens, and other encumbrances in and to the Trademarks; and

WHEREAS, Assignors desire to sell, convey, transfer, assign, and deliver to Assignee, and Assignee desires to acquire, all of Assignors' right, title and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby releases any and all claims, liens, and other encumbrances in and to the Trademarks; and Assignors do hereby sell, assign, transfer, convey and deliver to Assignee, and Assignee purchases and acquires from Assignors, all of Assignors' right, title and interest in and to the Trademarks, the goodwill of the business symbolized by the Trademarks, all rights to sue, counterclaim, and to collect damages and payments for claims of past, present, and future infringements, unfair competition or misappropriations thereof, and all income, royalties, damages and payments now or hereafter due or payable with respect thereto, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives.




