THIS ASSIGNMENT is made the 31st day of January 2012

BETWEEN:

- (1) **GlaxoSmithKline PLC**, a company incorporated in England and Wales (registered number 03888792) whose registered office is at 980 Great West Road, Brentford, Middlesex TW8 9GS, United Kingdom ("**GSK PLC**"), acting as agent for the Assignors (as defined below); and
- (2) **Medtech Products, Inc.**, a company incorporated in Delaware, US (registered number 2654109), whose registered office is at 90 North Broadway, Irvington, NY 10533, US (the "**Assignee**").

WHEREAS:

- (A) Among others, GSK PLC and Prestige Brands Holdings, Inc. ("**Prestige**"), the parent company of the Assignee, have entered into a business sale and purchase agreement, as amended from time to time, dated as of 20 December 2011 (the "**Sale Agreement**"), pursuant to which Prestige has agreed to purchase, or to procure that a designated purchaser, being the Assignee, shall purchase, various assets including the Trade Marks (as defined below).
- (B) Each Assignor is:
 - (i) the respective registered proprietor of the trade marks (and applicant for registration of the trade mark registrations) for which it is named as proprietor (or applicant, as applicable) in Schedule 2 to this Assignment (the "**Trade Marks**"); and/or
 - (ii) the beneficial owner of one or more of the Trade Marks,in each case, as applicable.
- (C) Each Assignor has agreed to assign all rights that it owns in any of the Trade Marks to the Assignee, and has appointed GSK PLC as agent for this purpose.

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. DEFINITIONS AND INTERPRETATION

Capitalised terms used, but not otherwise defined, in this Assignment shall have the meaning given to them in the Sale Agreement, and the following words and expressions shall have the following meanings:

"**Assignors**" means the persons specified as such in Schedule 1 to this Assignment, and "**Assignor**" shall be construed accordingly.

2. ASSIGNMENT

- 2.1 In consideration of the payment set out in the Sale Agreement in respect of the Trade Marks (receipt of which is hereby acknowledged by GSK PLC), each Assignor hereby assigns to the Assignee all its right, title and interest in and to the Trade Marks together with all goodwill of the business in relation to which such Trade Marks are used (but no other or greater goodwill), including all rights, privileges and advantages thereto including, without limitation, the right to take proceedings and recover damages and obtain all other remedies in respect of past infringements thereof to hold unto the Assignee absolutely.
- 2.2 GSK PLC and the Assignee agree that GSK PLC is entering into this Assignment on the basis set out in Schedule 3 to this Assignment. GSK PLC hereby represents and warrants to the Assignee that prior to the execution of this Assignment it has been validly appointed as agent of the Assignors for the purposes of this Assignment. In the event that such agency is found to be invalid, GSK PLC shall immediately procure that the Assignors effect the assignments referred to in clause 2.1 above.
- 2.3 This Assignment is executed for the purpose of evidencing and confirming the transfer of the Trade Marks to Assignee as provided in the Sale Agreement. Nothing contained in this Assignment is intended to modify any of the provisions of the Sale Agreement as they relate to the Trade Marks, including any of the representations, warranties, covenants or indemnities set forth in the Sale Agreement. In the event of any conflict between this Assignment and the Sale Agreement, the Sale Agreement will prevail.

3. COUNTERPARTS

- 3.1 This Assignment may be executed in any number of counterparts, and by GSK PLC and Assignee on separate counterparts, but shall not be effective until each party has executed at least one counterpart.
- 3.2 Each counterpart shall constitute an original of this Assignment, but the counterparts shall together constitute but one and the same instrument.

3. GOVERNING LAW AND JURISDICTION

- 3.1 This Assignment shall be governed by and construed in accordance with English law. Any matter, claim or dispute arising out of or in connection with this Assignment, whether contractual or non-contractual, is to be governed by and determined in accordance with English law.
- 3.2 The courts of England are to have jurisdiction to settle any dispute, whether contractual or non-contractual, arising out of or in connection with this Assignment. Any Proceedings shall be brought only in the courts of England.
- 3.3 Each party waives (and agrees not to raise) any objection, on the ground of *forum non conveniens* or on any other ground, to the taking of Proceedings in the courts of England. Each party also agrees that a judgment against it in Proceedings brought in

England shall be conclusive and binding upon it and may be enforced in any other jurisdiction.

- 3.4 Each party irrevocably submits and agrees to submit to the jurisdiction of the English courts.

IN WITNESS WHEREOF this Assignment has been executed by or on behalf of the parties on the date first above written.

TAGAMET 200 and tablet device



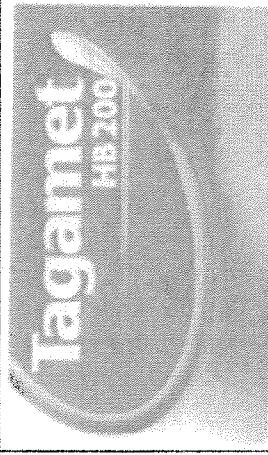

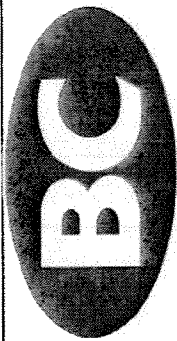
