Assignee shall be responsible for recording this Assignment with the various Trademark Offices.
2. Transfer of Files. Assignor shall deliver to Assignee Assignor's files in its possession concerning the Registrations.
3. Further Assurances. Assignor shall execute and deliver to Assignee such other documents and assignments as may be necessary to consummate or implement this Assignment. Assignee shall be responsible for any recordings with the various Trademark Offices.
4. Binding Effect. This Assignment shall be binding upon and shall inure to the benefit of the Parties, and their respective successors and assigns.


