NOTICE OF TRADEMARK SECURITY AGREEMENT
(FOR RECORDATION PURPOSES)

This Notice of Trademark Security Agreement, dated as of October 25, 2011, is made with regard to DC HOLDING COMPANY II, INC., a Delaware corporation, GROVES SUPPLY CORPORATION, a Texas corporation, DOALL COMPANY, an Illinois corporation, CONTINENTAL MACHINES, INC., a Minnesota corporation, CONTOUR SAWS, INC., an Illinois corporation, and GREENLEE DIAMOND TOOL COMPANY, an Illinois corporation (collectively, the "Debtors" and each a "Debtor"), having an address for notice at 1480 S. Wolf Road, Wheeling, IL 60090 and Wells Fargo Bank, National Association ("Lender"), having an address for notice at 150 S. Wacker Drive, Suite 2200, Chicago, Illinois 60606.

R E C I T A L S:

The Debtors and the Lender have entered into a Credit and Security Agreement dated as of October 25, 2011 (as the same may hereafter be amended, supplemented or restated from time to time, the "Credit Agreement") setting forth the terms on which the Lender may now or hereafter make certain loans or other financial accommodations to or for the account of the Debtor.

Pursuant to the terms of the Trademark Security Agreement, Debtor has granted a security interest in favor of the Lender in and with respect to the entire right, title, and interest of Debtor in the trademarks identified in the attached schedule (the "Trademarks"), together with the goodwill of the business symbolized by said Trademarks.
