INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "**Assignment**"), dated as of December 31, 2011 (the "**Effective Date**"), is made and entered into by and between Hercules Chemical Corporation, Inc., a New Jersey corporation ("**Seller**"), and HCC Holdings, Inc., an Ohio corporation ("**Purchaser**"). Purchaser and Seller are sometimes referred to herein, individually, as a "**Party**" and, collectively, as the "**Parties**." Capitalized terms used but not otherwise defined herein shall have the meanings assigned to such terms in the Purchase Agreement (as hereinafter defined).

WHEREAS, Purchaser and Seller have entered into a certain Asset Purchase Agreement, dated as of December 31, 2011 (the "**Purchase Agreement**"), pursuant to which Purchaser is acquiring certain assets of Seller.

WHEREAS, Seller has agreed, pursuant to the Purchase Agreement, to sell, transfer, convey, assign, grant, and deliver, or cause to be sold, transferred, conveyed, assigned, granted, and delivered to Purchaser, and Purchaser has agreed to purchase from Seller, all of Seller's right, title, and interest in and to the Purchased Assets purchased by Purchaser pursuant to the Purchase Agreement.

NOW, THEREFORE, pursuant and subject to the terms and conditions set forth in the Purchase Agreement, including, without limitation, the representations, warranties, covenants, and agreements set forth therein, and in consideration of the promises hereof, the covenants and agreements hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Party, intending to be legally bound, does hereby agree as of the Effective Date as follows:

1. Seller hereby sells, transfers, conveys, assigns, grants, and delivers to Purchaser all right, title, and interest in and to (i) all of Seller's patents, patent applications, trademarks, service marks, trademark applications, service mark applications, copyrights, copyright applications, trade names and domain names and other intellectual property (the "**Seller's Intellectual Property**"), whether or not registered, including, without limitation, the Seller's Intellectual Property identified in **Section 2.01(c) and (d)** of the Disclosure Schedules to the Purchase Agreement and set forth in the attached **Exhibit A** hereto, and further including all rights provided therein in the United States and throughout the world, including as provided by treaty or convention, (ii) all goodwill associated with such Seller's Intellectual Property and Seller's business and (iii) all rights to sue and recover and retain damages and costs and attorneys' fees for present and past infringement of any of the rights in such Seller's Intellectual Property.

2. Seller shall take any and all additional actions as may be necessary or appropriate to effect the transactions contemplated by this Assignment at Purchaser's expense. Such actions may include, without limitation: the execution of all papers and documents and swearing of all lawful oaths to perfect the rights in Seller's Intellectual Property; the execution of all documents to record the assignments and transfers made in this Assignment and the filing of such documents with the appropriate domestic and foreign governmental authorities; and assisting Purchaser with the procurement, maintenance, enforcement, and defense of such Seller's Intellectual Property without charge to Purchaser.

3. Seller may not assign, delegate, or transfer its rights or obligations under this Assignment without the prior written consent of Purchaser. This Assignment is binding upon and shall inure to the benefit of the Parties and their respective successors and permitted assigns.

4. This Assignment may be executed in two (2) or more counterparts, each of which shall be deemed an original, and it shall not be necessary in making proof of this Agreement or the terms of this

Agreement to produce or account for more than one (1) of such counterparts. Facsimiles or other electronic transmissions of signatures shall be deemed to be originals.

5. If any provision of this Assignment shall be invalid or unenforceable, in whole or in part, or as applied to any circumstance, under the laws of any jurisdiction which may govern for such purpose, then such provision shall be deemed to be modified or restricted to the extent and in the manner necessary to render the same valid and enforceable, either generally or as applied to such circumstance, or shall be deemed excised from this Assignment, as the case may require, and this Assignment shall be construed and enforced to the maximum extent permitted by law as if such provision had been originally incorporated herein as so modified or restricted, or as if such provision had not been originally incorporated herein, as the case may be.

6. This Assignment shall be governed by and construed and enforced in accordance with the laws of the State of Ohio, as applicable to agreements executed and entirely performed in such State and without giving effect to the choice of law rules of such State.

2. Seller shall take any and all additional actions as may be necessary or appropriate to effect the transactions contemplated by this Assignment at Purchaser's expense. Such actions may include, without limitation: the execution of all papers and documents and swearing of all lawful oaths to perfect the rights in Seller's Intellectual Property; the execution of all documents to record the assignments and transfers made in this Assignment and the filing of such documents with the appropriate domestic and foreign governmental authorities; and assisting Purchaser with the procurement, maintenance, enforcement, and defense of such Seller's Intellectual Property without charge to Purchaser.

If any provision of this Assignment shall be invalid or unenforceable, in whole or in part, or as applied to any circumstance, under the laws of any jurisdiction which may govern for such purpose, then such provision shall be deemed to be modified or restricted to the extent and in the manner necessary to render the same valid and enforceable, either generally or as applied to such circumstance, or shall be deemed excised from this Assignment, as the case may require, and this Assignment shall be construed and enforced to the maximum extent permitted by law as if such provision had been originally incorporated herein as so modified or restricted, or as if such provision had not been originally incorporated herein, as the case may be.

6. This Assignment shall be governed by and construed and enforced in accordance with the laws of the State of Ohio, as applicable to agreements executed and entirely performed in such State and without giving effect to the choice of law rules of such State.
