**RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATIONS**

February 15, 2012

Reference is hereby made to that certain Intellectual Property Security Agreement, dated as of May 3, 2010, as amended, restated, modified, renewed or extended from time to time (the "Agreement"), executed by Zeno Corporation, a Delaware corporation ("Grantor"), whose address is 450 Gears Road, Suite 600, Houston, TX 77067 in favor of Comerica Bank ("Grantee"), a Texas banking association, whose address is 39200 Six Mile Road, Mail Code 7578, Livonia, Michigan 48152, which was recorded in the United States Patent and Trademark Office ("USPTO") on November 21, 2011, at Reel 004664 Frame 0440, pursuant to which the Grantor assigned and granted to Grantee, a security interest in and to all of Grantor's right, title and interest in and to certain trademarks, including those trademarks specifically listed on Exhibit A attached hereto (the "Marks") and the goodwill associated therewith; and

WHEREAS, Grantee wishes to terminate the Agreement and release, retransfer and reassign to Grantor, without representation or warranty, all of Grantee's right, title and interest in and to the Marks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantee hereby terminates the Agreement and releases, retransfers and reassigns to Grantor, without representation or warranty, all of Grantee's right, title and interest in and to the Marks and the goodwill associated therewith.
