**GRANT OF SECURITY INTEREST  
IN TRADEMARKS**

February 14, 2012

**WHEREAS**, JAMBA JUICE COMPANY, a California corporation (the "Pledgor"), with an office at 6475 Christie Avenue, Suite 150, Emeryville, California 94608, is the owner of the U.S. Trademark registrations listed on Schedule A attached hereto (all such trademarks, the "Trademarks"); and

**WHEREAS**, the Pledgor, along with Jamba, Inc., a Delaware corporation, Jamba Juice Advertising Fund Inc., a Delaware corporation, and Talbott Teas Inc., a Delaware corporation, has entered into a Security Agreement, dated as of February 14, 2012 (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), in which the Pledgor has agreed with Wells Fargo Bank, National Association (the "Bank"), with offices at 301 South College Street, 28<sup>th</sup> Floor, Charlotte, North Carolina 28288, to execute this Grant of Security Interest in Trademarks ("Grant");


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the payment and performance of the Secured Obligations (as defined in the Security Agreement), the Pledgor does hereby grant to the Bank a security interest in all of its right, title and interest in and to the Trademarks, and Trademark registrations, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks. This Grant has been given in conjunction with the security interest granted to the Bank under the Security Agreement, and the provisions of this Grant are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference.
