TRADEMARK RELEASE

THIS TRADEMARK RELEASE effective as of the 3rd day of June, 2011 by Bank of America, N.A., as successor-by-merger to LaSalle Bank National Association, in its capacity as administrative agent for the Lenders ("Agent").

WITNESSETH:

WHEREAS, Agent and OXY-DRY CORPORATION, BALDWIN TECHNOLOGY COMPANY, INC. and BALDWIN GRAPHIC SYSTEMS INC., each a Delaware corporation (collectively, "Grantor") were parties to that certain Patent and Trademark Security Agreement dated as of November 21, 2006 (the "Assignment"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Rights set forth on Schedule 1 hereto and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively, the "Trademark Rights"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark set forth on Schedule 1 hereto ; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark set forth on Schedule 1 hereto, or (b) injury to the goodwill associated with any Trademark set forth on Schedule 1 hereto .

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks and the Trademark Rights set forth on Schedule 1 hereto.
