INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (this "**Assignment**") is made and entered into effective as of October 24, 2011, by and between BOSTWICK LABORATORIES, INC., a Delaware corporation ("**Assignor**"), and AMERICAN INTERNATIONAL BIOTECHNOLOGY, LLC, a Virginia limited liability company ("**Assignee**"). All capitalized terms used in this Assignment and not defined herein shall have the meanings ascribed to them in the Asset Purchase Agreement among Assignor, Assignee, David G. Bostwick, M.D. and The Bostwick Group, LLC, dated as of the date hereof (the "**Agreement**").

Assignor is the owner of all right, title and interest in and to the applications and registrations, along with all goodwill associated therewith, set forth in the attached Schedule A (the "**Trademarks**"). As contemplated by the Agreement, Assignee wishes to acquire from Assignor, and Assignor wishes to transfer to Assignee, all of Assignor's right, title, interest, and related goodwill in the Trademarks, and the parties hereto wish to record such acquisition in the United States Patent and Trademark Office. Pursuant to the Agreement, Assignee is acquiring the AIBiotech Business of the Assignor in connection with which Assignor has a *bona fide* intent to use the Trademarks in the pending intent-to-use applications set forth in Schedule A.

NOW, THEREFORE, in consideration of the promises, the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor and Assignee hereby act and agree as follows:

1. **Conveyance.** Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the Trademarks, including all goodwill associated therewith, all proceeds therefrom and the right to bring an action at law or in equity for any infringement, dilution or violation of any of the Trademarks occurring prior to the date hereof, and to collect all damages, settlements and proceeds relating to the Trademarks, together with that portion of Assignor's business with which it has a *bona fide* intent to use the Trademarks.

2. **Recordation.** Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration for the Trademarks to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks.

3. **Miscellaneous.**

This Assignment is subject to all the terms and conditions of the Agreement, and this Assignment shall not modify the applicable terms and conditions of the Agreement.

This Assignment shall be governed by and construed and enforced in accordance with the internal laws of the State of Delaware, without regard to the conflict of laws rules thereof.

This Assignment may be executed in two or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.

Any signature page hereto shall be deemed an original if delivered by facsimile or similar electronic means, including without limitation by electronic mail in portable document format.

This Assignment may be amended, modified, superseded or canceled only by a written instrument executed by all of the parties hereto.



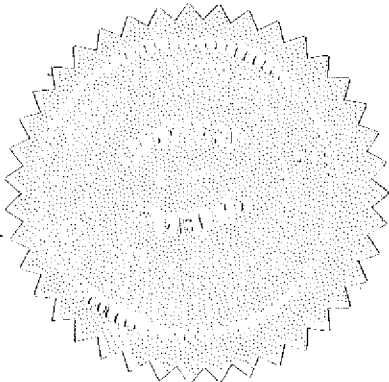

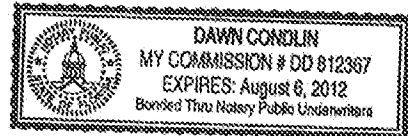
