NOTICE OF SECURITY INTEREST



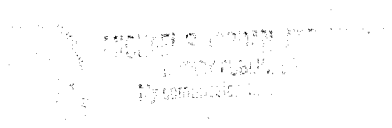

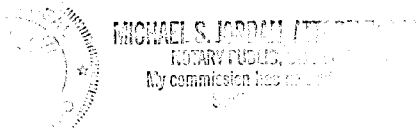
