ASSIGNMENT OF TRADEMARK AND REGISTRATION

ACTIVESSENCE®

This Assignment of the Trademark ACTIVESSENCE (the "Assignment") is made and entered on FEB 17th, 2012, by and between **Triarco Industries, Inc.**, a corporation organized and existing under the laws of the State of New Jersey, having a principal place of business at 400 Hamburg Turnpike, Wayne, New Jersey 07470 ("Triarco (NJ)"), and **Triarco Industries, Inc.** organized and existing under the laws of the State of Delaware, having a place of business at 400 Hamburg Turnpike, Wayne, New Jersey 07470 ("Triarco (DE)") (collectively referred to as the "Parties," and individually, a "Party.")

Whereas, Triarco (NJ) is the record owner of the mark ACTIVESSENCE (words only) (hereinafter, the "Mark") and the Registration of the Mark on the Principal Register of the United States Patent and Trademark Office (the "USPTO"), Registration No. 2307643, with a filing date of December 29, 1993, and a registration date of January 11, 2000 (the "Registration"); and

Whereas, Triarco (NJ) desires to sell, convey, transfer, assign and deliver to Triarco (DE), and Triarco (DE) desires to acquire from Triarco (NJ), all of Triarco (NJ)'s interest in and to the Mark and the Registration upon the terms and subject to the conditions set forth herein.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. ASSIGNMENT:

(a) Triarco (NJ) hereby agrees to sell, convey, transfer, assign and deliver to Triarco (DE), its successors and assigns, and Triarco (DE) hereby agrees to acquire from Triarco (NJ), upon the terms and subject to the conditions set forth in this Assignment, all of Triarco (NJ)'s right, title and interest, whether statutory or at common law, in and to the Mark and the Registration, together with the goodwill of the business symbolized by the Mark throughout the world, together with all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.

(b) Triarco (NJ) agrees to execute further papers and to do such other acts as may be necessary and proper to vest full title in and to the Mark in Triarco (DE).

2. TRIARCO (NJ)'S REPRESENTATIONS:

(a) Triarco (NJ) represents and warrants that Triarco (NJ) is the sole owner of the Mark and the Registration and that Triarco (NJ) has the power and authority to enter into this Assignment.

(b) Triarco (NJ) further represents and warrants that the rights transferred in this Assignment are free of lien, encumbrance or adverse claim of any nature or kind whatsoever.

3. GOVERNING LAW:

This Assignment shall be governed by and construed in accordance with the laws of the State of New Jersey.

4. BINDING EFFECT:


