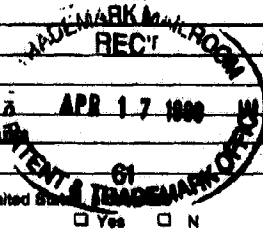

ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK (this "Assignment") is entered into as of July 30, 1996 by WILKINS COFFEE, INC. a Virginia corporation ("Wilkins"), in favor of ROYAL CUP, INC., a Delaware corporation ("Royal Cup").

Recitals

A. Wilkins has adopted and used in its business a trademark which is registered in the United States Patent and Trademark Office under number 1696319, dated June 23, 1992 (the "Trademark").

B. Wilkins has heretofore entered into an Asset Purchase and Sale Agreement dated July 30, 1996 by and among Wilkins, Daniel Abensohn, Susan Abensohn, Mark Abensohn, Seymour S. Abensohn, The Estate of Selma D. Abensohn, Joseph B. Churchman, Jane P. Churchman, Regis C. Cupples, Arthur Eden, Ann Eden, Toby Greene, Stanley Hayman, The Estate of James S. Hiatt, Albert Hinton, Jennifer McDaniel, Sidney Z. Mensh, Rose B. Mensh, James K. Pickard, Julia L. Pickard, James B. Pittleman, Susan B. Pittleman, Dennis F. Ratner, Joseph Sitrick, Gary R. Stern, Janet I. Stern, Ralph W. Stern, Dolores F. Stern, Samson B. Stern, Frances Stern, Saul I. Stern, Marcia Stern, and Helda B. Zeldon, (jointly and severally the "Shareholders"); and Royal Cup (the "Purchase Agreement") for the sale of the assets and all attending good will of Wilkins to Royal Cup.

Agreement

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Wilkins and Royal Cup hereby agree as follows:

1. Wilkins does hereby convey, assign, transfer and set over unto Royal Cup, and its respective successors and assigns, all right, title and interest of Wilkins in, to and under the Trademark and in the registration thereof, a copy of which is attached hereto as Exhibit A and made a part hereof, together with the goodwill of the business in connection with which such mark is used.

2. Wilkins hereby agrees that it will use its best efforts to take, or cause to be taken, such action, to execute and deliver, or cause to be executed and delivered, such additional documents and instruments and to do, or cause to be done, all things necessary, proper, or advisable under the provisions of this Assignment and under applicable law to consummate and make effective the assignment contemplated under this agreement.
