ARTICLES OF AMENDMENT

OF

RUSSELL'S FRUIT JUICE COMPANY, INC.

January 30, 1990

The Articles of Incorporation of RUSSELL'S FRUIT JUICE COMPANY, INC. shall be amended as follows:

Article I of the Articles of Incorporation shall be deleted in its entirety and the following shall be added in its place:

"Article I.

The name of the corporation shall be:

FLORIDA BOTTLING, INC."

The foregoing amendment was adopted on January 30, 1990, by the sole shareholder and director of the corporation, pursuant to Section 607.181(3), Florida Statutes, as evidenced by their signatures on a Unanimous Consent manifesting their intention that the foregoing amendment to the Articles of Incorporation be adopted.

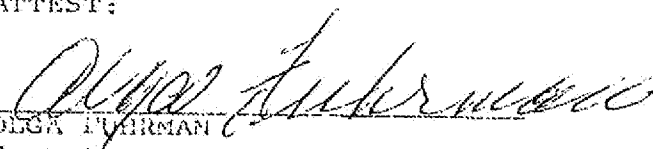

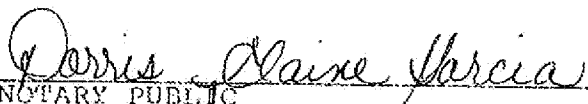
