**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

This Intellectual Property Assignment Agreement (“Assignment Agreement”), dated as of June 30, 2011 (the “Effective Date”), is by and between EducationDynamics, Inc., a Delaware corporation (the “Assignor”), and ConnectEDU, Inc., a Delaware corporation (the “Assignee”).

**RECITALS**

A. Assignor and Assignee have entered into that certain Asset Purchase Agreement (the “Purchase Agreement”), dated as of the date hereof.

B. Pursuant to the terms of the Purchase Agreement, Assignor has agreed to sell, assign, transfer, convey and deliver to Assignee certain intellectual property assets, among other assets, and Assignee has agreed to purchase, acquire and accept from Assignor such assets for the consideration specified in the Purchase Agreement.

C. The parties wish to confirm and memorialize their agreement with respect to the assignment, transfer, and conveyance of the Company Intellectual Property Rights to Assignee under the Purchase Agreement, and through this Assignment Agreement, the parties are confirming and consummating such transactions contemplated by the Purchase Agreement.

**1. Definitions.**

Capitalized terms used but not otherwise defined in this Assignment Agreement shall have the meanings set forth in the Purchase Agreement.

**2. Assignment of Intellectual Property Rights.**

For good and valuable consideration, the receipt of which is hereby acknowledged, and in further consideration of the mutual covenants and agreements contained in the Purchase Agreement, and expressly subject thereto, Assignor and Assignee agree as follows:

(a) Assignor does hereby sell, assign, transfer, convey and deliver unto Assignee, or its designees, all worldwide rights, title and interest in all Company Intellectual Property Rights owned by the Assignor as of the date hereof including, but not limited to those described by the following specific provisions and accompanying Schedules 1-3 of this Assignment Agreement.

(b) Assignor does hereby sell, assign, transfer, convey and deliver unto Assignee, the right to sue for enforcement or infringement of the Company Intellectual Property Rights, the right to damages for past infringement or unfair competition of such Company Intellectual Property Rights, the right to register, renew or otherwise apply for protection of the Company Intellectual Property Rights, and the right to license, sublicense, sell and transfer or otherwise convey any of the above to others.

**3. Trademarks.**

For good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby conveys, transfers, assigns, delivers and contributes to Assignee or it designee, all of Assignor's title and interest of whatever kind existing as of the date hereof in and to the Marks comprising the Company Intellectual Property Rights, including the Marks set forth in **Schedule 1** hereto, together with (1) the goodwill of the business relating to the products in respect upon which the Marks are used and for which they are registered; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and (3) all rights to sue for past, present and future infringements or misappropriations of the Marks.

**4. Copyrights.**

For good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby conveys, transfers, assigns, delivers and contributes to Assignee all of Assignor's right, title and interest of whatever kind existing as of the date hereof in and to the Copyrights and software comprising the Company Intellectual Property Rights worldwide, including the Copyrights and software set forth in **Schedule 2** hereto, including all income, royalties, and damages hereafter due or payable to Assignor with respect to the Copyrights and software. As applicable, Assignor hereby authorizes the Register of Copyrights and any other relevant authority to issue all copyright registrations and renewals related to the Copyrights to Assignee as the assignee of Assignor's entire right, title and interest therein.

**5. Domain Names.**

For good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign, transfer, and convey unto Assignee, its successors and assigns, all of its right, title and interest in and to all the Net Names, including the domain names listed on **Schedule 3** attached hereto.

**6. Execution of Recordable Assignments.** The parties agree to execute the accompanying Trademark Assignment and Copyright Assignment and that such assignments shall be recordable at Assignee's discretion, expense, and risk.

**7. Counterparts; Effectiveness.** This Assignment Agreement may be executed in any number of counterparts, all of which shall be considered one and the same agreement and shall become effective when one or more such counterparts have been signed by each party and delivered to the other party.

**8. Captions.** The captions herein are included for convenience of reference only and shall be ignored in the construction or interpretation hereof.


9. The parties are executing this Assignment Agreement in accordance with and expressly subject to all of the terms and conditions of the Purchase Agreement.


