## AGREEMENT REGARDING TRADEMARK ASSIGNMENT

This Agreement ("Agreement") is made by and between VKR Holding A/S with registered seat at Breetevej 18, DK-2970 Hørsholm, Denmark ("VKR") and Heliodyne Corporation with registered seat 4910 Seaport Avenue, Richmond, CA 94804 ("Heliodyne"), collectively the "Parties".

WHEREAS, on or about July 30, 2010, the Parties entered into a "Product Development Agreement" (the "Development Agreement").

WHEREAS, Article 6(3) of the Development Agreement provides: "All IPR, Trademarks, logos, [...], and other proprietary rights related to the Products, any new products [...] shall be the property of VKR regardless of whether registrations related to such rights were made by the VKR or Heliodyne."

WHEREAS, Article 1(4) of the Development Agreement provides: "Trademarks means all registered and unregistered trademarks, trademark applications, trademark registrations, [...] and any renewals and extensions thereof, now or hereafter registered or used by the Heliodyne or its subsidiaries or licensees [...]"

WHEREAS, the Parties wish to clarify and confirm the meaning of the language of the Development Agreement.

NOW, THEREFORE, the Parties agree as follows:

The Parties acknowledge and agree that:

1. The US trademark "SOME LIKE IT HOT", Registration No. 3863094, Registration Date 10/19/2010 ("Trademark") is a trademark within the meaning of Article 1 (4) of the Development Agreement.
2. Article 6 (3) shall be interpreted as an assignment and transfer of the Trademark together with the goodwill represented by the Trademark to VKR in accordance with the terms of the Development Agreement, effective as of the date of such agreement.
3. VKR is hereby authorized and instructed to record the transfer and assignment of the Trademark to VKR at the United States Patent and Trademark Office.
