CONFIRMATION ASSIGNMENT OF REGISTERED TRADEMARK

WHEREAS, New Focus, Inc. 

Assignor agrees to cooperate with Assignee to record this Assignment in the United States Patent and Trademark Office and to extend such other cooperation and perform such other acts as may be necessary or appropriate, in the opinion of Assignee, to convey, establish, evidence, maintain, defend and enforce Assignee's rights in the trademark NEW FOCUS; and Assignor hereby irrevocably appoints Assignee and any of its officers as Assignor's attorney in fact to undertake such acts in Assignor's name.
