To Whom It May Concern:


The undersigned attorney of record respectfully requests that the above Assignment recorded against Registration No. 2665738 at Reel 004602/Frame 0989 in the name of David C Cook be nullified. At the time of execution of the foregoing Assignment, Reg. No. 2665738 was a jointly owned registration between Integrity Media, Inc. (prior owner) and Direct Holdings Americas, Inc. The Assignment recorded at Reel 004602/Frame 0989 assigned 100% ownership from Integrity Media, Inc. to David C Cook. **AFFIDAVIT OF KOURTNEY A. MULCAHY

I, Kourtney A. Mulcahy, an attorney, state under penalty of perjury as provided by law pursuant to 28 U.S.C. §1746 as follows:

1. I am the attorney of record representing David C Cook (“Assignee”) in the Assignment and Assumption of All Rights, Title, and Interest in the Intellectual Property acquired from Integrity Media, Inc. and Integrity Music, Inc. (the “Assignors”) and I have first hand knowledge of the facts set forth herein.

2. On August 11, 2011, Assignee submitted to the US Patent and Trademark Office (“USPTO”) for recording an Assignment of Intellectual Property Rights and attached Schedule A, which represented the trademark applications and registrations to be assigned to Assignee.

3. The Assignment submitted by Assignee was accepted and recorded by the USPTO Assignment Division on August 11, 2011 at Reel 4602/Frame 0989.

4. US Reg. No. 2665738, issued December 24, 2002 for TM: SONGS 4 WORSHIP was inadvertently included for recording on Page 4 of Schedule A.

5. Prior to the recording of Assignment by Assignee, US Reg. No. 2665738 for TM: SONGS 4 WORSHIP was a jointly owned trademark registration of Integrity Media, Inc. and Direct Holding Americas, Inc.

6. Assignor, Integrity Media, Inc. inadvertently assigned 100% ownership interest of Reg. No. 2665738 to David C Cook. Assignor was entitled to assign only its 50% ownership interest in the mark to David C Cook.

7. Direct Holdings Americas, Inc. did not authorize the assignment of its 50% ownership interest in the mark to David C Cook.

8. In light of the joint ownership of Reg. No. 2665738 by Integrity Media, Inc. and Direct Holdings Americas, Inc., Assignee, David C Cook, respectfully requests that the Assignment document recorded on August 11, 2011 at Reel 4602/Frame 0989 be nullified with regard to Reg. No. 2665738 only.

9. Therefore, Assignee respectfully request that the trademark ownership for Reg. No. 2665738 for the TM: SONGS 4 WORSHIP reflect the joint ownership by Integrity Media, Inc. and Direct Holdings America, Inc.
