

Section 3. Date of Organization. The date the Articles of Organization of the Company were filed with the Indiana Secretary of State was December 12, 2002.


ARTICLE II

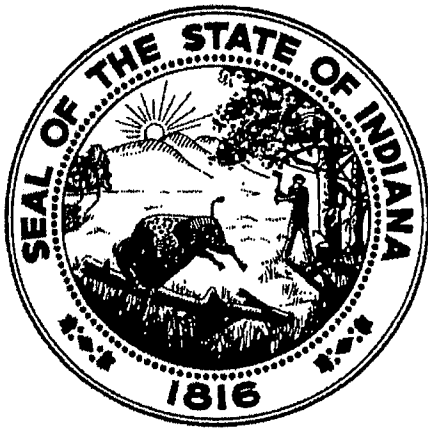
