RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is made as of February 24, 2012 by BT FUNDING CORP., a Delaware corporation ("BT Funding").

WITNESSETH:

WHEREAS, Bijoux Turner LLC, a Delaware limited liability company (the "Grantor") and BT Funding, were parties to (i) that certain Trademark Security Agreement, dated as of February 28, 2006 and (ii) that certain Trademark Security Agreement, dated as of September 24, 2009 ((i) and (ii) collectively, the "Security Agreements"), pursuant to which the Grantor granted a security interest to BT Funding in the Property, as defined in the Security Agreements including without limitation the trademarks, trademark licenses and all goodwill of the business connected with the use of and symbolized by, each trademark set forth in Schedule I attached hereto; and

WHEREAS, BT Funding recorded a security interest in said Property with the Assignment Division of the United States Patent and Trademark Office, each on the date and the Reel and Frame as set forth in Schedule I attached hereto.

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. BT Funding hereby releases its security interest in the Property granted to BT Funding pursuant to the Security Agreements.
2. BT Funding, to the extent granted in either Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by BT Funding, all of its right, title and interest in and to the Property and all goodwill associated therewith granted to BT Funding pursuant to the Security Agreements.
3. The Grantor and its legal counsel and agents shall be authorized to file this Release with the United States Patent and Trademark Office.
4. Upon the request of Grantor and at the Grantor's expense, BT Funding further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release.

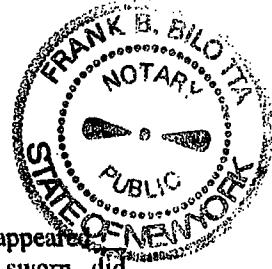
