TERMINATION OF SECURITY INTEREST IN TRADEMARK

WHEREAS, The ManiaTV! Network, Inc., a Delaware corporation ("ManiaTV Inc.") was the former owner of record of the trademark listed on the attached Exhibit A (the "Trademark"), issued by the United States Patent and Trademark Office ("USPTO");

WHEREAS, ManiaTV Inc. entered into that certain Intellectual Property Security Agreement dated as of December 17, 2007 (the "Security Agreement") with Comerica Bank ("Secured Party") whereby ManiaTV Inc. granted a security interest in the Trademark to Comerica, and a true and correct copy of such agreement was recorded by the USPTO on January 29, 2008 at Reel 3706, Frame 0708;

WHEREAS, the Secured Party also caused the filing of a UCC-1 Financing Statement with the Delaware Secretary of State on December 27, 2007 (Filing No. 20080023141) in connection with the Security Agreement;

WHEREAS, on April 3, 2009, Drew Massey purchased the Trademark from ManiaTV Inc. pursuant to that certain Asset Purchase & Clean Rights Agreement, a true and correct copy of which was recorded by the USPTO on April 14, 2009 at Reel 3970, Frame 0106; and

WHEREAS, the Secured Party desires to release its security interest in the Trademark and to terminate any and all effect of the Security Agreement on the Trademark;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. terminates any and all effect of the Security Agreement on the Trademark and releases its security interest in and lien on the Trademark without recourse or representation or warranty, express or implied;
2. authorizes the filing and recording of this release with the USPTO, and also hereby authorizes and requests the Commissioner of the USPTO to note and record the existence of the release hereby given; and
3. authorizes the filing of a UCC-3 Financing Statement Amendment with the Delaware Secretary of State and to take such other action as may be necessary to amend any financing statements filed with respect to the Security Agreement in connection with the Secured Party's above-described release of its security interest in and lien on the Trademark.

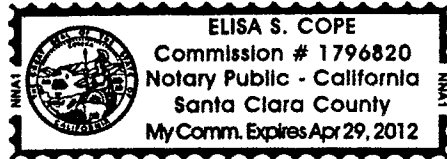
