**NOTICE OF RELEASE OF  
SECURITY INTEREST IN UNITED STATES TRADEMARKS  
(Lee Enterprises, Incorporated)**

WHEREAS, pursuant to the Security Agreement dated as of November 21, 2008 among Lee Enterprises, Incorporated, certain subsidiaries of Lee Enterprises, Incorporated and Deutsche Bank Trust Company Americas, as Collateral Agent ("Grantee") (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"), Lee Enterprises, Incorporated, a Delaware corporation ("Grantor") granted to Grantee a security interest in all right, title and interest of Grantor in and to the Grantor's Intellectual Property, including its Trademarks (including, without limitation, those items listed on Exhibit A). Capitalized terms used herein without definition are used as defined in the Security Agreement.

WHEREAS, by a Grant of Security Interest in United States Trademarks dated November 21, 2008 (the "Trademark Security Agreement") and recorded in the United States Patent and Trademark Office on December 17, 2008 at Reel 3905 Frame 0401, Grantor, by reference to the Security Agreement, confirmed its grant of security interest to Grantee specifically in its Trademarks.

WHEREAS, Grantee wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of the security interest in the Trademarks.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the Security Agreement, the receipt of which is hereby acknowledged, Grantee hereby terminates, releases and discharges all of its security interest in the Trademarks (including, without limitation, those items listed on Exhibit A) and any and all such right, title and interest (if any) that the Grantee may have in the Trademarks shall hereby cease and become void.

The Grantee agrees, at the Grantor's expense, to cooperate with the Grantor, to execute, deliver and file any additional documents, and to do such other acts as the Grantor may reasonably request to effect the release, termination or discharge of the Grantee's security interest in the Trademarks.
