**RELEASE OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this “Release”) is made as of February 28, 2012 (the “Effective Date”) by and between Barclays Bank PLC, with principal offices at 745 Seventh Avenue, New York, New York 10019, as Collateral Agent (“Agent”), and Renal Advantage Inc., a Delaware Corporation, and RAI II, LLC, a Delaware limited liability company, each having its principal office at 115 East Park Drive, Suite 300, Brentwood, Tennessee 37027 (together, “Obligor”).

**WHEREAS**, Obligor and Agent entered into that certain Grant of Security Interest in United States Trademarks dated December 17, 2010 (the “Trademark Security Agreement”) pursuant to that certain Guarantee and Collateral Agreement by and among Obligor, the other assignors from time to time party thereto, and Agent dated December 17, 2010 (the “Security Agreement”);

**WHEREAS**, Obligor granted to Agent a continuing security interest in and to, inter alia, all of Obligor’s right, title and interest in and to all of the Marks (as defined in the Trademark Security Agreement), including, without limitation, the trademark registrations and trademark applications set forth on Schedule A attached hereto (collectively, the “Trademarks”);

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 17, 2010, at Reel 4436, Frame 0129; and

**WHEREAS**, Obligor has satisfied its Obligations (as defined in the Trademark Security Agreement) to Agent.

**NOW, THEREFORE**, Agent hereby terminates, cancels and releases any and all security interests and rights of setoff it has against the Trademarks together, in each case, with the goodwill of the business symbolized by the Trademarks, including the trademark registrations and applications, any and all proceeds or products thereof, and all causes of action arising from any infringement of such Trademarks or unfair competition regarding the same.

Agent shall, at Obligor’s sole expense, take all further actions, and provide to Obligor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Obligor, in writing, to more fully and effectively effectuate the purposes of this Release.

This Release shall be binding upon Obligor’s and Agent’s legal representatives, assigns and successors. Agent hereby authorizes Obligor to make such filings with the United States Patent and Trademark Office as may be reasonably determined by Obligor to be required to record and evidence the release and termination of Agent’s security interests in the Trademarks evidenced hereby.


