RELEASE OF TRADEMARK SECURITY INTERESTS

WHEREAS, St. Louis Cardinals, LLC, successor in interest to St. Louis Cardinals, L.P., is a Missouri limited liability company, having its principle place of business at 700 Clark Street, St. Louis, Missouri 63102 (“Debtor”);

WHEREAS, PNC Bank, National Association, successor in interest by merger to National City Bank, as successor in interest by merger to The Provident Bank, is a national association (“Secured Party”) and is the holder of a security agreement granting a security interest in certain trademarks dated December 23, 2003 and recorded in the U.S. Patent and Trademark Office (“USPTO”) on January 15, 2004, at reel/frame number 2778/0244 (the “2003 Security Agreement”);

WHEREAS, to the extent such document was not previously released, amended or restated by the 2003 Security Agreement or other document, Secured Party is the holder of a security agreement granting a security interest in certain trademarks dated March 21, 1996 and recorded in the USPTO on May 6, 1996, at reel/frame number 1461/0314 (the “1996 Security Agreement”); and


WHEREAS, Secured Party desires to terminate the 2003 Security Agreement, and to the extent it still is in force to terminate the 1996 Security Agreement, and to execute and deliver to Debtor all deeds, assignments and other instruments as may be reasonably necessary to release the security interests relating to the trademarks set forth in the 2003 Security Agreement and the 1996 Security Agreement, which trademarks include those identified on Schedule A annexed hereto and made a part hereof (the “Trademarks”).

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby relinquishes unto Debtor the continuing security interest in and lien on the Trademarks and otherwise assigns, grants and conveys to Debtor any and all rights Secured Party may have in or to the Trademarks in order to revest in Debtor full and unencumbered title to said Trademarks.
