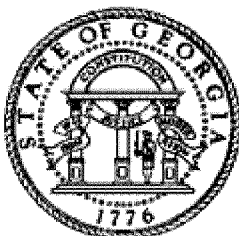

Pursuant to the provisions of Section 14-2-1105 and Section 14-2-1107 of the Georgia Business Corporation Code ("GBCC"), the undersigned business entity does hereby certify as follows:

1. The name and state of incorporation of each corporation which is merging is as follows:
 - (i) OpenSpan, Inc., a Georgia corporation ("OpenSpan-Georgia"); and
 - (i) OpenSpan, Inc., a Delaware corporation ("OpenSpan-Delaware"). ✱

OpenSpan-Georgia, shall be merged with and into OpenSpan-Delaware, with OpenSpan-Delaware being the surviving corporation. The name of the surviving corporation is OpenSpan, Inc.

2. The certificate of incorporation of OpenSpan-Delaware, as in effect immediately before the merger shall be the certificate of incorporation of the surviving corporation.


