
(1) The "Intellectual and Proprietary Assets", (CYB-IP) including the following:

(2) All future CYB-IP ownership rights previously acquired by Belanger and Raymond Perron, CTI, Richard Levine, their associates, partners and legal entities that they have an interest in, direct and indirect, and corporate, LLC's and any other entities that they have an interest in, direct and indirect. In addition to the above the present Intellectual Property also includes all further additions made to the present day while in the possession of Cimtec, Raymond Perron, and/or any other party involved directly or indirectly with the CYB-IP.
