The parties have executed this assignment effective as of February 29, 2012.



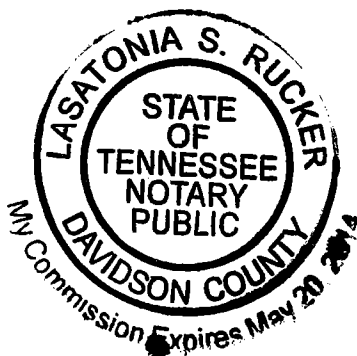

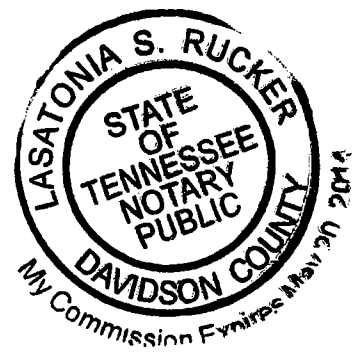
