## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "IP Assignment") is entered into effective as of 23 December, 2011 (the "Effective Date"), by and between Rosewood Hotels and Resorts, L.L.C., a Delaware limited liability company ("Assignor") and New World Hotel Management (BVI) Limited, a British Virgin Islands company ("Assignee").

### 1.0 BACKGROUND.

1.1 Assignor is a direct or indirect wholly-owned subsidiary of Assignee and Assignee desires to consolidate its intellectual property under common ownership.

### 2.0 ASSIGNMENT.

2.1 In consideration of the sum of ten dollars and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, sells, transfers and sets over unto Assignee its entire right, title and interest in and to all intellectual property, proprietary rights and intangible property owned by Assignor throughout the world, including, without limitation (i) all trademarks, service marks, brand names, d/b/a's, Internet domain names, logos, symbols, trade dress, trade names and other indicia of origin, all applications and registrations for all of the foregoing, together with the associated goodwill therewith and symbolized thereby (including the trademarks and domain names set forth in Exhibit A attached hereto), (ii) all published and unpublished works of authorship and copyrights (including computer software) and all applications and registrations for all of the foregoing, (iii) all trade secrets and know-how and (iv) all patents, inventions, discoveries and ideas and all applications and registrations for all of the foregoing, including, in each case, all income, royalties, damages and payments now or hereafter due or payable with respect thereto in and to all causes of action (either in law or in equity) and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this IP Assignment (collectively, the "Intellectual Property").

### 3.0 MISCELLANEOUS.

3.1 Assignor agrees to assist Assignee, in a commercially reasonable manner, to take all actions and execute all documents necessary or desirable to evidence, record and perfect the assignment of the Intellectual Property, including the obligation to sign all lawful papers and electronically transfer the Internet domain name registrations, including, without limitation, all divisional, renewal, and extension applications, and make all rightful oaths in execution thereof; and will generally do everything commercially reasonably possible at no cost or expense to Assignor to aid Assignee, its successors, assigns, and nominees to obtain and enforce proper protection for the Intellectual Property in all countries, this obligation to be binding upon Assignor and Assignor's successor; and shall not enter into any agreement in conflict with this IP Assignment.

3.2 This Assignment shall be governed by, and construed and enforced in accordance with, the laws of the State of Texas and the federal laws of the United States of America, without

reference to principles of conflicts of law that might cause the laws of any other jurisdiction to apply.


3.3 This Assignment may be executed in counterparts, each of which, when executed, shall constitute one and the same agreement.
