## **TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of February 29, 2012, by GE BUSINESS FINANCIAL SERVICES INC. formerly known as Merrill Lynch Business Financial Services Inc., in its capacity as Administrative Agent for certain Lenders ("Agent").

W I T N E S S E T H:

WHEREAS, Agent and Coalition America, Inc., a Georgia corporation ("Grantor"), were parties to that certain Trademark Security Agreement dated as of January 31, 2008 (the "Assignment"), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the "Trademarks") and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent and the financial institutions (collectively, the "Lenders") from time to time party to that certain Credit Agreement dated as of January 31, 2008 by and among Grantor, the other "Borrowers" party thereto, Agent and the Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on February 1, 2008, at Reel 3709, Frame 0864; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

(i) each Trademark listed on Schedule I annexed hereto, together with any reissues, continuations or extensions thereof;

(ii) the good will of the business connected with the use of, and symbolized by, each Trademark; and


(iii) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks and the Trademark Collateral.
