RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of February 16, 2012 ("Effective Date") by Newstar Financial, Inc. (the "Administrative Agent") in favor of Inscape Midco, Inc., a Delaware corporation ("Borrower"), Inscape Holdings, Inc., Delaware corporation, Inscape Publishing, Inc. a Delaware Corporation, and CLC Holding Company, a Delaware corporation (collectively, "Grantors"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

WHEREAS, Grantors, the Administrative Agent and the Lenders party thereto entered into that certain Credit Agreement, dated as of August 20, 2007 (the "Credit Agreement"), pursuant to which the Lenders agreed to make certain loans and other extensions of credit to Borrower;

WHEREAS, in connection with the Credit Agreement, Grantors and the Administrative Agent entered into that certain Security Agreement, dated as of August 20, 2007 (the "Security Agreement"), pursuant to which Grantors granted the Administrative Agent a security interest in the intellectual property of Grantors;

WHEREAS, pursuant to the Security Agreement, Grantors and the Administrative Agent entered into that certain Intellectual Property Security Agreement, dated as of August 20, 2007 (the "Intellectual Property Security Agreement"), for the purpose of recording the security interest of the Administrative Agent with respect to the intellectual property of Grantors, including, without limitation, the trademarks set forth on Schedule A hereto (as further defined in the Intellectual Property Security Agreement, the "Intellectual Property");

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on August 21, 2007 at Reel 3605, Frame 0449; and

WHEREAS, Borrower has paid all of its outstanding indebtedness to the Administrative Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Lenders, (i) terminates, cancels and releases any and all security interests in or Liens upon the trademarks set forth on Schedule A hereto and other Intellectual Property and (ii) re-assigns to Grantors any right, title and interest it may have in, to and under the Intellectual Property.


