RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of March 1, 2012, is made by Wilmington Trust, National Association (as successor to Wilmington Trust FSB), a federal savings bank located at Corporate Client Services, Suite 1290, 50 South Sixth Street, Minneapolis, MN 55402, as Collateral Agent (the "Collateral Agent") under the Security Agreement (as defined below). Terms used in this Release and not herein defined shall have the meanings set forth in the Security Agreement.

WHEREAS, in connection with the Security Agreement dated as of February 19, 2010, by and among RDA Holding Co., The Reader's Digest Association (the "Borrower"), Allrecipes.com, Inc. (the "Company"), and the Grantors identified therein, to JP Morgan Chase Bank, N.A., Wells Fargo Bank, N.A., and the Collateral Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Security Agreement"), and pursuant to the Grant of Security Interest in Patent Rights dated as of February 19, 2010, and the Grant of Security Interest in Trademark Rights dated as of February 19, 2010 (collectively, the "Grants of Security Interest"), the Company granted security interests in certain patents and trademarks owned by the Company, including the patents and trademarks listed on Exhibit I attached hereto (all such rights, collectively, the "Intellectual Property Collateral"); and

NOW THEREFORE, the Collateral Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Grants of Security Interest or any other agreement or document delivered in connection with the Security Agreement, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in the Intellectual Property Collateral to the Company.

The Collateral Agent agrees, at the Borrower's expense, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization reasonably required or desirable to effect the release of the Collateral Agent's security interest in the released Intellectual Property Collateral described herein.

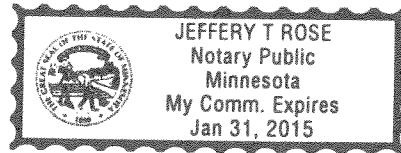
