**REASSIGNMENT AND
PARTIAL RELEASE OF TRADEMARKS**

This Reassignment and Partial Release of Trademarks dated as of February 14, 2012 (this "Release") is made by ServisFirst Bank, acting in its capacity as secured party (in such capacity, the "Secured Party"), in favor of Hoffman Media, LLC (the "Debtor") for the benefit of Debtor's affiliated company, Martha Pullen Company, Inc. ("MPC").

WITNESSETH

WHEREAS, pursuant to that certain Security Agreement, dated as of December 30, 2009, recorded in the records of the United States Patent and Trademark Office on January 4, 2010 beginning at Reel 4123, Frame 0819 from the Debtor in favor of Secured Party, the Debtor granted to Secured Party, among other things, a continuing security interest in certain Debtor trademarks, including the Trademark set forth on the Schedule attached hereto (the "Subject Trademark") by means of assignment and Debtor hereby represents and warrants to Secured Party that the Subject Trademark constitutes an asset utilized primarily in Debtor's MPC business;

WHEREAS, the Debtor and Hoffman Media, Inc. have requested Secured Party to reassign the Subject Trademark and release its security interest solely in the Subject Trademark in the records of the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby reconvey and reassign to Debtor the Subject Trademark and does release, without recourse, representation or warranty, its security interest in, to or under solely the Subject Trademark, together with the goodwill of the business solely to the extent symbolized thereby, provided, however, that if Debtor is granted a license or other right to use the Subject Trademark, then any such right, title, interest, or license retained by Debtor, shall be and remain subject to the security interests of Secured Party.

Secured Party shall execute any further documents as may be reasonably requested by Debtor and at Debtor's expense in order to fully effectuate the release of its security interest in the Subject Trademark.

This Release shall be governed in all respects by the laws of the State of Alabama.




