Assignor agrees to provide all reasonable assistance and cooperation including the signing of any forms or relevant documents to enable Assignee to record this assignment with the applicable government agencies.

Assignor represents and warrants that to the best of its knowledge the Mark has been in use in the United States for the goods listed in the subject registration during the past 5 years and the subject registration is not vulnerable to cancellation on the ground of non-use in the United States.




