WHEREAS, Assignor is the owner of all right, title, and interest in and to the Trademark, has the full right to make the conveyance herein and represents and warrants to the Assignee that Assignor has not transferred, assigned, hypothecated or granted a security interest in the Trademark to any third party.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, as of February 24, 2012 Assignor hereby sells, assigns, transfers and conveys unto Assignee all right, title and interest in and to the Trademark together with the goodwill of the business symbolized by the Trademark, along with that portion of the business that is existing and ongoing and all rights and causes of action to recover past, present or future damages, royalties, fees, profits or other relief, including but not limited to, equitable and injunctive relief ensuing from infringement of the Trademark.

Assignor, without further consideration, agrees to execute and deliver other documents and take other and further actions as may be necessary to more fully effectuate or consummate the subject matter of this Intellectual Property Assignment.

This Intellectual Property Assignment shall be binding upon and inure to the benefit of the employees, officers, agents, representatives, heirs, administrators, executors, successors, transferees and assigns of the parties.

This Intellectual Property Assignment is entered into solely to effect the assignment of the Trademark pursuant to the terms of the Purchase Agreement and is subject to all of the terms and conditions thereof. Nothing in this Intellectual Property Assignment shall modify the terms and conditions of the Purchase Agreement in any way. In the event that there is a conflict between the terms of this Intellectual Property Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall prevail and govern. If any term or provision in this Intellectual Property Assignment is held to be unenforceable, the remainder of the Intellectual Property Assignment shall not be affected. The recitals set forth above are hereby incorporated into this Intellectual Property Assignment.
