TRADEMARK ASSIGNMENT AGREEMENT

This **TRADEMARK ASSIGNMENT AGREEMENT** ("Agreement") is made effective as of the 23 day of FEBRUARY, 2012 ("Effective Date"), by and between **GE FANUC Automation Americas Inc.** ("Assignor") and **Fanuc FA America Corporation** ("Assignee").

WHEREAS, Assignor is the owner of all right, title and interest in and to U.S. Registration No. 3101115 ("*i* ADAPT®") ("Trademark"), and the goodwill associated with the Trademark (the "Goodwill");

WHEREAS, Assignee is desirous of acquiring all rights, title and interest in and to the Trademark and Goodwill.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers, and conveys to Assignee, the entire right, title, and interest in and to the Trademark and the Goodwill to be held and enjoyed by Assignee, its successors, assigns and other legal representatives, as fully and completely as the same would have been held by Assignor if this assignment had not been made. Without limiting the generality of the foregoing, Assignor hereby assigns, transfers, and conveys unto Assignee causes of action and rights to bring suit for infringement of the Trademark.
2. Assignor hereby authorizes and requests any official throughout the world whose duty it is to register and record ownership in intellectual property rights, including the United States Patent and Trademark Office, to record Assignee as the assignee and owner of the Trademark.
3. Assignor hereby agrees to execute and deliver at a future date any additional documents that Assignee determines may be necessary or desirable, or that may be required under federal or state law, to preserve and protect, and to perfect Assignee's ownership of, the Trademark and Goodwill. Assignor hereby grants to Assignee a Power of Attorney (which power is hereby acknowledged to be coupled with an interest and irrevocable) and appoints Assignee to serve as its agent and Attorney-in-fact, with powers of substitution, in each case for the limited purposes of executing and delivering such documents and doing such acts in Assignor's place and stead as Assignor would otherwise be obligated.
4. This Agreement shall be governed by, and construed in accordance with, the laws of the State of Illinois, without regard to any conflict of laws provisions.

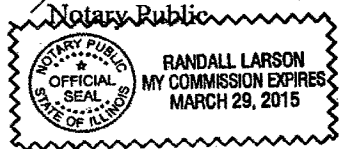


