


GRANT OF TRADEMARK SECURITY INTEREST

June 30, 2011

WHEREAS, the undersigned (each a "Grantor" and collectively the "Grantors"), own and use in their business, and will in the future adopt and so use, various intangible assets, including the Trademark Collateral (as defined below); and

WHEREAS, Playcore Wisconsin, Inc., a Wisconsin corporation ("Company"), has entered into a First Lien Credit Agreement dated as of June 30, 2011 (said Credit Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Credit Agreement") with the financial institutions named therein (collectively, together with their respective successors and assigns party to the Credit Agreement from time to time, the "Lenders"), and BNP Paribas, as Administrative Agent for the Lenders (in such capacity, "Secured Party") pursuant to which Lenders have made certain commitments, subject to the terms and conditions set forth in the Credit Agreement, to extend certain credit facilities to Company; and

WHEREAS, Company, Holdings, PCH, the Subsidiary Grantors, BNP Paribas, as First Lien Administrative Agent (as defined in the Intercreditor Agreement), and BNP Paribas, as Second Lien Administrative Agent (as defined in the Intercreditor Agreement) have entered into an Intercreditor Agreement dated as of June 30, 2011 (as it may hereinafter be amended, restated, supplemented or otherwise modified from time to time, the "Intercreditor Agreement"); and

WHEREAS, Company may from time to time enter, or may from time to time have entered, into one or more swap agreements (collectively, the "Lender Hedge Agreements") with one or more Hedge Agreement Counterparties; and

WHEREAS, certain Grantors have executed and delivered that certain Subsidiary Guaranty dated as of June 30, 2011 (said Subsidiary Guaranty, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Guaranty") in favour of Secured Party for the benefit of each of Lenders and any Hedge Agreement Counterparties, pursuant to which such Grantors have guaranteed the prompt payment and performance when due of all obligations of Company under the Credit Agreement and the other Loan Documents (as defined in the Credit Agreement) and all obligations of Company under the Lender Hedge Agreements, including, without limitation, the obligation of Company to make payments thereunder in the event of early termination thereof; and

WHEREAS, pursuant to the terms of a Security Agreement dated as of June 30, 2011 (said Security Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Security Agreement"), among Grantor, Secured Party and the other grantors named therein, Grantor has created in favor of Secured Party a security interest in, and Secured Party has become a secured creditor with respect to, the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted by Grantor to Secured Party pursuant to the Security Agreement, Grantor hereby grants to Secured Party a security interest in all of Grantor's right, title and interest in and to the following, in each case whether now or hereafter existing or in which Grantor now has or hereafter acquires an interest and wherever the same may be located (the "Trademark Collateral"):
