## **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS** (this "Termination and Release"), dated as of February 15, 2012, is made by Ares Capital Corporation in its capacity as administrative agent for the Lenders (as defined in the Credit Agreement referred to below) (in such capacity, the "Administrative Agent") under that certain Grant of Security Interest in Trademark Rights, effective as of July 22, 2011 (the "Trademark Security Agreement") among AmSafe, Inc., and Precision Weaving, Inc. (collectively, the "Grantors") and the Administrative Agent (in such capacity, the "Grantee"), in connection with that certain Credit Agreement, dated as of July 22, 2011 (as amended from time to time, the "Credit Agreement"), among AP Global Holdings, Inc., AP Global Acquisition Corp., the Lenders, and the Administrative Agent.

**WHEREAS**, the Guarantee and Collateral Agreement dated as of July 22, 2011 (as amended and/or supplemented from time to time, the "Guarantee and Collateral Agreement"; capitalized terms used but not otherwise defined herein shall have the meaning given to them in the Guarantee and Collateral Agreement), made by AP Global Holdings, Inc., AP Global Acquisition Corp. and certain of its Subsidiaries, including the Grantors, in favor of the Administrative Agent, provided for the execution of the Trademark Security Agreement;

**WHEREAS**, pursuant to the Trademark Security Agreement, the Grantors granted to the Grantee for the benefit of the Lenders a continuing security interest in, and a setoff right against, all of the Grantors' right, title and interest in, to, and under the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"):

- (a) all Trademarks of the Grantors, including those listed on Schedule I hereto; and
- (b) all Goodwill connected with the use of, and symbolized by, each Trademark; and

**WHEREAS**, the Grantee has terminated the Trademark Security Agreement and agreed to release, relinquish and discharge its right, title, and interest in the Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agrees as follows:

1. The Grantee hereby releases, relinquishes, and discharges in its entirety any and all right, title and interest (including, without limitation, security interests) it has against the Trademark Collateral, including the security interest which was recorded with the United States Patent and Trademark Office on July 22, 2011 at Reel 004589, Frame 0281.

2. The Grantee authorizes and requests the United States Patent and Trademark Office to record this Termination and Release against the Trademark Collateral, as applicable.

3. This Termination and Release shall be governed by the law of the State of New York.
