RELEASE OF SECURITY INTEREST

WHEREAS, LEGACY.COM, INC., a Delaware corporation ("Assignor"), having its chief executive office at 820 Davis Street, Suite 210, Evanston, Illinois, entered into a Security Agreement (the "Security Agreement") dated as of November 1, 2002 with certain parties (the "Secured Parties") represented by Tribune Company, as administrative agent ("Administrative Agent"), and gave a Collateral Assignment of Intellectual Property (the "Assignment") of even date therewith in favor of the Secured Parties, to induce the Secured Parties to make a loan to Assignor;

WHEREAS, Assignor granted to Secured Parties a security interest in and lien upon its Collateral (as defined in the Security Agreement) and Intellectual Property Rights (as defined in the Assignment), including, without limitation, the United States trademarks, service marks and trade names and United States trademark and service mark registrations and trade name, trademark and service mark applications set forth on Schedule A attached hereto (the "Trademarks, Service Marks, Trade Names and Registrations and Applications"); and

WHEREAS, Assignor has fulfilled its obligations and paid its indebtedness under the Security Agreement and all obligations of the Secured Parties to make further loans to Assignor have been terminated.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Administrative Agent hereby releases, on its own behalf and on behalf of the Secured Parties, its security interest in and lien upon the Collateral, including, without limitation, the Intellectual Property Rights, and the Trademarks, Service Marks, Trade Names and Registrations and Applications.
