

TERMINATION OF PATENT AND TRADEMARK SECURITY AGREEMENT

This Termination of Patent and Trademark Security Agreement (this "Termination"), dated as of November 29, 2010, is executed by COÖPERATIEVE CENTRALE RAIFFEISEN-BOERELEENBANK B.A. as successor in interest to Landsbanki Islands hf ("Secured Party"), Croeselaan 28, 3521 CB Utrecht, the Netherlands in favor of MAREL MEAT PROCESSING INC. (formerly known as Stork Townsend Inc.) an Iowa corporation (the "Company"), 2425 Hubbell Ave, Des Moines, IA 50317, USA.

RECITALS

WHEREAS, Company, certain Lenders and Secured Party, as Agent, entered in a certain Senior Facilities Agreement, dated April 28, 2008 (the "Facilities Agreement"); and

WHEREAS, in connection with the Facilities Agreement Company and Secured Party entered into a certain Patent and Trademark Security Agreement dated May 13, 2008 (the "Security Agreement"), and

WHEREAS, pursuant to the Security Agreement, Company granted to Secured Party a security interest in certain "Collateral" including certain patents and trademarks; and

WHEREAS, the Facilities Agreement and the Security Agreement have been terminated.

NOW, THEREFORE, Secured Party agrees as follows:

1. Secured Party is executing and delivering this Termination as further evidence of the termination of the Security Agreement.

2. Secured Party claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Security Agreement, and, accordingly, Secured Party expressly terminates its security interest in the patents and trademarks listed on Exhibit A hereto, which security interest was evidenced by the recognition of the Security Agreement with the United States Patent and Trademark Office on June 2, 2008, in Reel/Frame 003736/0284 and Reel/Frame 021006/0953.
