## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This Termination of Security Interest in Trademarks (this "Termination"), dated as of February 28, 2012 is executed by CP II UT Coinvestors, LLC (aka CP II UTC LLC), a Delaware limited liability company (the "Creditor"), to terminate the Junior Lien Security Agreement dated as of January 21, 2009 (the "Security Agreement"), by and among the Creditor, in its capacity as Collateral Agent for certain agents and lenders, and Universal Trailer Holdings Corp., Universal Trailer Corp., Universal Trailer Cargo Group, Inc. (formerly known as Haulmark Industries, Inc.), Exiss Sooner, LLC (formerly known as Universal Trailer Corporation Horse/Livestock Group), Sooner Trailer Manufacturing Company, LLC (formerly known as Sooner Trailer Manufacturing Company), all Delaware corporations and limited liability companies, Featherlite, Inc. (formerly known as Featherlite Manufacturing, Inc.) a Minnesota corporation, each with an address of 11590 Century Boulevard, Suite 103, Cincinnati, OH 45246 (collectively, the "Borrowers").

1. Termination of Security Agreement. The Security Agreement dated as of January 21, 2009 between the Creditor and each Borrower identified above is terminated, and all obligations and rights of the parties in the Junior Lien Security Agreement are terminated, null and void.

2. Filing Releases. The Creditor agrees to file, or have filed on its behalf, releases and terminations of its security interest in the Trademarks of the Borrowers listed on the Exhibit to this Termination by filing this Termination with the United States Trademark Office.

3. Headings. Section headings in this Termination are included for convenience of reference only and shall not relate to the interpretation or construction of this Termination.

IN WITNESS WHEREOF, this Termination of Security Interest has been duly executed by the Creditor as of February 28, 2012.

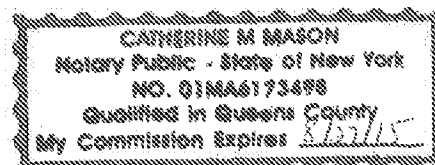
