together with the goodwill of the business symbolized thereby in connection with the goods for which the Mark is used (the "Goods").





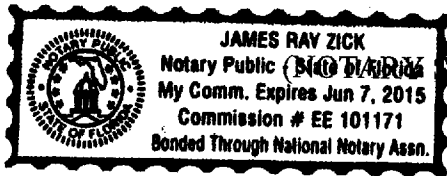
